Prosecution v. Janis Karpinski

Overview

Janis Karpinski is a former Brigadier General in the United States Army who was in charge of the 800th Military Police Brigade in the U.S. occupation of Iraq in 2003-2004. Her brigade was in charge of managing multiple detention facilities, including one of the most notorious of camps, the Abu Ghraib prison. At the end of 2003, there were serious accusations regarding the mistreatment and abuse of Iraqi prisoners at Abu Ghraib. It was exposed through photographs and testimonies reflecting physical abuses, shame and other degrading treatment conducted by the U.S. personnel. Such disclosures created outrage in the international community that led to military inquiries. Karpinski was charged with the fact that she did not supervise prison activities properly. Prosecutors believed that, though there was no sign that she herself executed or directly ordered the abuse, her withdrawal, lack of supervision and enforcement of standards opened the door to a culture of misconduct. The testimony of witnesses suggested she made infrequent trips to the prison, abdicated major duties without monitoring, and overlooked abuse. She was the commanding officer, thus was held accountable for the behaviors of her subordinates. Karpinski refused this by saying that she was a scapegoat and that it was policies of interrogation issued by other higher-level military intelligence officers, which she had no control of. However, her suspension was followed by a demotion to the rank of colonel and official removal of her command, which became one of the most high profile accountability measures in the wake of the Abu Ghraib scandal.

Timeline

- 2003: Karpinski takes command of the 800th MP Brigade in Irag.
- **2003–2004**: Reports emerge of abuse, torture, and humiliation of Iraqi detainees at Abu Ghraib.
- Jan 2004: U.S. Army investigates; Karpinski suspended.
- 2005: Demoted to Colonel; she publishes her memoir denying responsibility.
